4. Health Director Updates:

2023-2024 Health Programming:

- Annual Year End Reports for 2022-23 are complete.
- Electronic Medical Records (EMR):
 - o EMR to produce data information and charts
 - Deb, Brittany, Audrey- Anna to be trained on this end of the EMR.
 - Health staff are responsible for entering data important for staff to document everything.
 - Documenting helps organize what you see and helps formulize the next steps and helps coworkers know if something has already been completed so no duplication occurs or triggers for the client.
 - Will be having mandatory training for Health staff who see clients will be in the fall over 8 weeks.
- MWT:
 - Waiting for ATV that was previously purchased.
- Public Health:
 - Health Fair is going to be in September.

Staffing Updates:

- 3 resignations
 - Amanda King: starting school for RPN
 - Jesse Colson: starting school for RPN

- Audrey- Anna Colson is our Community Health Representative (CHR).
- Registered Dietitian waiting to hear back
 - DOH to contact
- Mental Wellness Team:
 - Covers 3 regions
 - Have to look at what works and what can be changed- high amounts of travel.
 - Program Manager (PM) was posted, not enough applicants. Re-evaluating.
- Staff Evaluations are almost complete.

Expression of Interest: To Expand and Enhance Interprofessional Primary Care Teams:

- Application and support letters submitted Friday, June 16, 2023.
- Staff Needed: 1.0 FTE Administrative Assistant; 1.0 FTE Navigator; 1.0 RAAM Clinic- Social Worker-BSW; 1.0 FTE Registered Nurse Case Coordinator.
- Healing Room at the hospital needs to be used and people need to know the room is open and available for use. Our people need more support and the healing room can be used for family and patients, and can be used to close the gap between discharging patients and the Wasauksing Nursing Station.
