5. Health Director Updates:

5.1 2024-2025 Health Programming:

- Community Health Representative
 - Surveillance in the school continues.
 - Summer students are a part of the surveillance activities.

• CARA:

- The "Ball Club" for both boys and girls planned for August as their season ends in July.
- Both Male and Female adult teams have been established.
- New ball equipment is ordered.

Home and Community Care:

- Currently services 71 clients both on and away from the community we receive provincial monies that allows staff to go into Parry Sound.
- Responsibilities of the new discharge planner is being put into place this week as she has completed her orientation, protocol agreements for services that may visit our members in the institutions to be outlined.

NNADAP

- There has been an increase in individual referrals.
- GAINS training no longer available referrals are being made to B'saani working well.

Traditional Healing Program

- Programming continues
- "Medicine Cupboard" is organized and set up as an apothecary- service is underway.
- o Electronic Medical Record (EMR) is to be updated to reflect traditional healing.
- Intake form to be established.

Mental Wellness Team:

Continues to provide support to 6 First Nations- Wasauksing, Dokis, Wahnapitae,
 Magnetewan, Henvey, and Nipissing.

Other:

- Preparing templates for year-end reports.
- Nursing Station exit door has been repaired (old entrance door).
- Babysitting course provided to the youth group approximately 18 people attended and received certificates
- Food handler's course to be offered will be one full day date TBD.
- Needing speed limit Signs coming up the hill by Nursing Station

- Looking into a shed for garden tools.
- Seniors/Elders Trip to Chimnissing Hawaiian Day July 10, 2024 PSW and nurses attending
- o Health Staff Retreat in Killarney is rescheduled to the Fall date TBD.

- Youth Canoe Trip: August 2024
- Beginning research project with Northern Ontario School of Medicine (NOSM) –

- Traditional Wellness Practitioner currently completing reference checks.

- Discharge Planner Carley Horne has joined the team part-time.

5.3 & 5.4 Quality Improvement Plan:

- Quality Improvement Plan 2023-2024

 - Chief and Council have acknowledged that the DOH is the Privacy Custodian and the Director of Health for the Quality Improvement Plan data.
- Quality Improvement Plan 2024-2025
 - To establish a staff working group.

5.5 Anishinabek Advisory Council on Health

- DOH has contacted the Council to be considered for the current vacancy on the Lake Huron region
- Meetings are four times a year.
- Council on Health is accountable to the Anishinabek Chiefs Committee on Health. The Anishinabek Nation Leadership Council and the Anishinabek Chiefs-in-Assembly; term of membership is three years.
